## DEADLINE

Nomination Form: December 15, 2014 for January 2015 deadline June 15, 2015 for July 2015 deadline

Application: January 10, 2015 (awarded in June) July 1, 2015 (awarded in December)

## DESCRIPTION

RPB Harold F. Spalter International Research Scholar Award covers round-trip travel expenses.

This program encourages established non-US scientists to engage in collaborative research in RPB-supported departments. RPB will provide a grant to the American institution to cover **one** roundtrip economy fare transportation cost; the host institution is responsible for all other expenses. The length of stay for the scheduled visit may vary from a few weeks to several months.

## ELIGIBILITY

- > RPB-supported chairs may nominate one scientist prior to the onset of the visit.
- As with all RPB awards, chairs may nominate only one person per grant category, per cycle. Any previous RPB grants must be fully spent and recognized as *terminated* by RPB before applying for another RPB grant. All RPB grants must remain free of institutional overhead and are non-transferable to other individuals or other institutions. Complete grant stipulations are included in award letters.

# REPORTING

- > RPB requires an annual interim report while the award is active. A final report is required once funds are expended.
- > Failure to properly report and credit research funded by RPB puts your grant at risk for termination.

## NOMINATION FORM AND APPLICATION SUBMISSION

**Nomination Form**: Nomination forms are a requirement. For the January 10 application deadline, nomination forms are due no later than December 15; for the July 1 application deadline, nomination forms are due no later than June 15. **Applications received without a prior nomination form will not be accepted.** Complete the nomination form and email to Pattie Moran at pmoran@rpbusa.org. Nomination forms should be sent as Word documents only.

**Application**: RPB will accept applications and *most* supporting documentation via the password-protected page on RPB's web site that has been established for application submission. Please note only one (1) upload, with application and all applicable supporting documentation, will be accepted per candidate. This upload must be received **no later than 11:59pm ET on the deadline date.**

- Upload your application and supporting documentation by browsing for them on your computer using the "Browse" button on the form.
- > Use the Message box to add any additional information, if any.
- > Before clicking "SendThisFile" to send your submission, check that the information is complete.
- > Click the "SendThisFile" button to send your application and supporting documentation.

## This upload must include three separate documents:

Two signed, completed application forms:

The third document must include, in PDF, in this order:

- The candidate's NIH-style biosketch, in PDF; limit five (5) pages. The candidate must adhere to current NIH format and instructions. If NIH-style biosketch is unavailable, please use RPB biosketch format at the end of the application. If RPB biosketch format is unnecessary, please delete pages from application before submitting. Candidate's biosketch and bibliography must be submitted in English.
- The primary collaborator's NIH-style biosketch, PDF; limit five (5) pages. The collaborator must adhere to current NIH format and instructions. Biosketches submitted in any other format will be disqualified.
- A statement from the chair which should describe the proposed research, what special expertise/skills the visitor will contribute, and how the collaboration will benefit both the host institution and the non-US scientist's home institution. Statement must be on letterhead, signed, in PDF, and addressed to "RPB's Review Committees". Limit to three (3) pages and font size 10-point or higher.
- The primary collaborator's signed, scientific statement, in PDF, outlining the research and objectives to be pursued in the collaboration. Limit statement to four (4) pages with references on a fifth page. Entire statement should not exceed five (5) pages. Font size 10-point or higher.

#### > No letters of recommendation are required for this application.

Materials received after the deadline will not be accepted. Incomplete submissions are not forwarded to RPB's review committees and are automatically declined. Notify RPB if there are any changes to the status of major pending grants or faculty members or recruits. If the deadline falls on a weekend or holiday, proposals will be accepted the first following business day. Do not alter application format. Do not include binders, manuscripts, reprints, or any information not required by RPB.

# **A. Personal Statement**

I have the expertise, leadership, training, expertise and motivation necessary to successfully carry out the proposed research project. I have a broad background in psychology, with specific training and expertise in ethnographic and survey research and secondary data analysis on psychological aspects of drug addiction. My research includes neuropsychological changes associated with addiction. As PI or co-Investigator on several university- and NIH-funded grants, I laid the groundwork for the proposed research by developing effective measures of disability, depression, and other psychosocial factors relevant to the aging substance abuser, and by establishing strong ties with community providers that will make it possible to recruit and track participants over time as documented in the following publications. In addition, I successfully administered the projects (e.g. staffing, research protections, budget), collaborated with other researchers, and produced several peer-reviewed publications from each project. As a result of these previous experiences, I am aware of the importance of frequent communication among project members and of constructing a realistic research plan, timeline, and budget. The current application builds logically on my prior work. During 2005-2006 my career was disrupted due to family obligations. However, upon returning to the field I immediately resumed my research projects and collaborations and successfully competed for NIH support.

# C. Contribution to Science

- 1. My early publications directly addressed the fact that substance abuse is often overlooked in older adults. However, because many older adults were raised during an era of increased drug and alcohol use, there are reasons to believe that this will become an increasing issue as the population ages. These publications found that older adults appear in a variety of primary care settings or seek mental health providers to deal with emerging addiction problems. These publications document this emerging problem but guide primary care providers and geriatric mental health providers to recognize symptoms, assess the nature of the problem and apply the necessary interventions. By providing evidence and simple clinical approaches, this body of work has changed the standards of care for addicted older adults and will continue to provide assistance in relevant medical settings well into the future. I served as the primary investigator or co-investigator in all of these studies.

- 2. In addition to the contributions described above, with a team of collaborators, I directly documented the effectiveness of various intervention models for older substance abusers and demonstrated the importance of social support networks. These studies emphasized contextual factors in the etiology and maintenance of addictive disorders and the disruptive potential of networks in substance abuse treatment. This body of work also discusses the prevalence of alcohol, amphetamine, and opioid abuse in older adults and how networking approaches can be used to mitigate the effects of these disorders.

Methadone maintenance has been used to treat narcotics addicts for many years but I led research that has shown that over the long-term, those in methadone treatment view themselves negatively and they gradually begin to view treatment as an intrusion into normal life. Elderly narcotics users were shown in carefully constructed ethnographic studies to be especially responsive to tailored social support networks that allow them to eventually reduce their maintenance doses and move into other forms of therapy. These studies also demonstrate the policy and commercial implications associated with these findings.
